Executive Director's Report

With a year of spectacular growth and achievement behind us we can reflect on the efforts of 2014/15 with a sense of immense pride and fulfillment. Royal Life Saving ACT has had a focus of developing partnerships and associations over the past 12 months and through this, has been rewarded with new opportunities in almost every area of operation.

The Canberra Labor Club's support has continued ensuring Swim and Survive is accessible and affordable for children at risk of missing out through their grass roots community contribution program. The Canberra Labor Club Swim 4 Life program enjoyed it's most successful year to date with over 150 Participants being nominated through Royal Life Saving ACT Community Partners; Barnardos Canberra, Marymead, and YWCA. Many thanks to RLSSA and the Swim and Survive fund who also contributed to these programs.

The ACT Aquatic Industry continued to recognize Royal Life Saving ACT as the peak industry body for Canberra and the region. Our professional Aquatic Facility Safety Assessment services assist all major leisure centres in the ACT with their continuous improvement of safety standards. These improvements and achievements were again celebrated at the annual ACT Aquatic Industry and Water Safety Awards. The awards were endorsed by Safe Waters ACT and proudly hosted by Royal Life Saving ACT with support from The Canberra Labor Club. Congratulations are due to the award winners -and a special mention for Florey Primary School on their 'Outstanding Commitment to Water Safety by an ACT Primary School' award.

Royal Life Saving ACT' has maintains a strong working relationship with the ACT Education and Training Directorate and is pleased at the Directorate's ongoing commitment to ensuring accessible Water Safety Education for all ACT public primary students.

This commitment was evident when the Directorate mandated Water Safety lessons, both pool and classroom based, for Year 2 students in 2015. Royal Life Saving ACT is proud to be developing and delivering these programs for the Education and Training Directorate in partnership with local aquatic centres.

At a national level RLSSA is leading the way in Drowning Prevention strategies and activities with the roll-out of the Australia-wide Inland Waterways Drowning Prevention Project. The project, specifically funded by the Australian Government, is providing interventions across the country with a focus on communities around rivers, lakes, ponds, creeks and dams. Royal Life Saving ACT implemented various activities across Canberra including a Cold Water Awareness campaign that consisted of the RLSSA mascot, Lochie the Lifeguard, visiting local schools and providing free Water Safety talks to primary students of all ages. Our staff, volunteers, members and ambassadors continue to be the life-force behind all that we do and achieve. Without such a dedicated team working day to day to accomplish our goals, Royal Life Saving ACT's impact would be significantly reduced. We thank each and every individual who has been involved over the last 12 months from paid employees right down to members of the community who may have purchased a sausage sizzle at one of our many community fundraising events! Moving into the new financial year and warmer weather, we encourage every Canberran to think about what the phrase "Everyone Can Be A Lifesaver" means to them. There are plenty of opportunities to get involved with Royal Life Saving activities in the ACT and we welcome all participation and contributions great and small!

Our Team

Jackie Rousseau came on board in January 2015 in the position of Project Officer for the nationally funded Inland Waterways Drowning Prevention Project (IWDP). Working closely with RLSSA national branch Jackie liaises with community, schools and local government to identify concerns and implement strategies for water safety concerns within the ACT. Jackie's outside-the-box approach saw the introduction of a brand new 'Cold Water Awareness' campaign in April 2015.

The Swimming and Water Safety team of Program Coordinators, Swimming Instructors and Activity Leaders delivered lifesaving lessons to over 7000 primary school students this year. Skills taught from the RLSSA Swim and Survive program ranged from treading water to performing CPR. Water Safety talks in ACT schools were made more available through the IWDP with many staff members taking advantage of the opportunity to branch out from their typical roles in the organisation and explore the diverse range of employment opportunities available through Royal Life Saving ACT.

Royal Life Saving ACT Trainers are the best in the industry. The entire training team, consisting of both employed casual trainers, and 'offsite' trainers delivering in their own school/ workplace, is dedicated to the provision of excellent training and assessment services. As a result, Royal Life Saving ACT learners and their employers are performing at an excellent standard across the Territory. This quality is demonstrated in the consistently high-percentage results achieved by ACT aquatic facilities in their annual Aquatic Facility Safety Assessments.

The Royal Life Saving Society's Aquatic Facility Safety Assessment (AFSA) is a well-respected process within the industry that serves to assist Aquatic Facilities in continuous improvement of safety standards. ACT Sport and Recreation Services currently require all ACT Government owned pool venues to undergo an AFSA annually. Other privately owned sites do the same as part of their own risk management processes. Royal Life Saving ACT issued a 5-star rating to 8 ACT public pool facilities in 2014/15.

Assessment safety scores were impressive for all participating venues during 2014/15. All facilities scored above 90% compliance fairing exceptionally well against the last reported National mean score of 80.1% (RLSSA State of the Industry Report 2013).



Legislation for the local aquatic industry is almost ready to change with the ACT's Public Baths and Bathing Act 1956 set to be replaced with the ACT Public Pools Act 2015 as of July 1st. Some of the criteria and standards within the new Act will reflect or supersede industry standards and recommendations set out by Royal Life Saving Society – Australia in the Guidelines for Safe Pool Operations. Royal Life Saving ACT and ACT Public pools were consulted during the process of the legislation review and are preparing for implementation at the start of the new financial year.

As an extension service from the AFSA, Royal Life Saving ACT provided signage assessment consultation services to Townsend + Associates Architects as they built a brand new architecturally designed pool space at the Embassy of the People's Republic of China in Yarralumla, Canberra. The challenge faced by the builders was to provide an aesthetically pleasing and clutter free environment whilst still upholding the Australian Standards for water safety signage.





Capacity Building for the benefit of Industry

Royal Life Saving ACT has worked continuously with aquatic industry stakeholders to ensure that products and services are current, valid and relevant to all who access them. In 2014/15 the partnerships that the organisation shares with ACT Public Pools were strengthened with newly available professional development workshops and initial consultation around the design, development and implementation of a new electronic industry network system. The web-based system would serve to offer Aquatic Facility managers, coordinators, and lifeguards a unique online hub with features such as:

- AFSA reports and results history;
- Learning resource library for both new and updating lifeguards;
- Automatic qualifications notifications;
- Unified industry incident reporting system;
- Links to Royal Life Saving ACT training history for individuals.

Royal Life Saving ACT hopes to explore the feasibility and concept of the system further in the New Year upon additional consultation with industry, government, and other relevant stakeholders.

ACT Lifeguard Challenge

This year Royal Life Saving ACT hosted the ACT Lifeguard Challenge with a new record number of participants. 40 local lifeguards and over 20 volunteers came together to enjoy the annual event which was held at the reigning champions' venue – Dickson Aquatic Centre.

Lifeguard Challenge events included obstacle swims, timed rescue races and specific rescue scenarios, however, the team relays and rope throw events were the standout favourites.

The ACT Lifeguard Challenge was first held in 2012 with just 20 lifeguards. Participation has doubled since and is not the only aspect of the event that is expected to grow next year. The rivalry between Dickson Aquatic Centre and the Australian Institute of Sport is also bound to reignite as teams begin training for next year's Challenge.

Special mentions go to Luke Hinchcliffe from the AIS who won his third Overall Male Title, and to Hannah Hobson for winning the Overall Female Title.


ACT Primary Schools' Swim and Survive



In 2014 Royal Life Saving ACT delivered Swim and Survive lessons to 4547 public primary school students through the ACT Primary Schools' Swim and Survive Program. The addition of another 2404 private school Swim and Survive participants saw a total of 7093 children receiving vital water safety and survival education.

Programs were held across multiple venues: Active Leisure Centre- Erindale, Lakeside Leisure Centre - Tuggeranong, Canberra Olympic Pool, Canberra International Sports and Aquatic Centre, and Gungahlin Leisure Centre.

Achievement results for students fell well below the Australian Water Safety Strategy target of Swim and Survive - Level 4. Only 1213 children were recorded to have achieved Level 4 or above, highlighting the need for school-based Swim and Survive programs in the ACT.



2014 was the last year of funding for the ACT Primary School's Swim and Survive program. The ACT Education and Training Directorate publicly announced the concept for the next phase of water safety education program in ACT Public Primary Schools via an open tender for the development and provision of a water safety and awareness program aimed specifically at Year 2 students. The concept was based on the ideal that every ACT public primary student would receive targeted water safety and awareness lessons before leaving primary school. Royal Life Saving ACT was successful in the bid for the tender and will commence delivery of the new Year 2 'AQUASAFE' program in July 2015. It is hoped that through observing the immediate benefits of the program for students that schools and parents will be reacquainted with the importance of maintaining water safety education within the curriculum, and continue to offer and advocate participation of every primary age group.



An anticipated increase in participation for school-based Royal Life Saving water safety education programs demands constant improvement and capacity building. Royal Life Saving ACT has this year designed a custom online enrolment application with local software developer Peter Ciceran from Naxikku. The online system will allow thousands of parents the ease of enrolling their child directly into their school's chosen Royal Life Saving ACT program. The direct enrolment process will make data entry a thing of the past, and reporting will be a breeze. Royal Life Saving ACT is looking forward to launching the new system at the start of the new financial year.

Deakin. The 3 hour designated timeslot offered free swimming, Swim and Survive lessons for adults and children, and Aqua Aerobics. The feedback for the program was overwhelmingly positive and due to the high demands for ongoing services and facilities, Royal Life Saving ACT, in partnership with Kingswim Deakin, continued to host sessions well after the 12 week funded period had ceased.

Royal Life Saving ACT is looking forward to assisting the community in finding a more sustainable model for the program so that sessions can continue in 2016.







In its fifth year, and again under the proud sponsorship of the Canberra Labor Club Group, the ACT Swim 4 Life program topped all previous participation levels and provided vital water safety and survival training for over 150 children. Swim 4 Life was expanded from one to two venues: Canberra International Sports and Aquatic Centre, and Lakeside Leisure Centre in Tuggeranong.

Royal Life Saving ACT's Community Partners YWCA Canberra, Marymead, and Barnardos once again provided nominations for children and families at risk of missing out on structured aquatic education. Lessons were held in school holidays and ran for 10 consecutive days with children receiving Swim and Survive level certificates upon completion

Hydrotherapy Rescue Training

Royal Life Saving ACT continued to provide basic life support and emergency management skills training for various hydro/physiotherapists this year. The training is essential for staff in case of incident or emergency at their hydrotherapy pool venues. Therapists from both The Canberra Hospital and Hughes Hydro in Canberra were recertified in Cardiopulmonary Resuscitation and basic water rescue and extraction techniques.

Royal Life Saving ACT believes itself to be one of Canberra's most trusted Registered Training Organisations and a leading provider of training in first aid and aquatic safety. With only one minor transition between water rescue units 'SISCAQU307A - Perform advanced water rescues' and 'SISCAQU318 - Perform advanced water rescues' 2014, the organisation's scope remained relatively unchanged. The introduction of a brand new Training Management system - VM Learning's "AXcelerate", in January 2015, has offered new possibilities in the management of participants' learning histories. Customer contact and general efficiency in managing course administration have also improved since the implementation of "AXcelerate".

As the only RTO in Canberra delivering full employment pathways and accredited training for lifeguards, the organisation employs strict quality assurance processes to ensure that the aquatic industry receives the most relevant and up to date content. Aquatic rescue training increased this year seeing 122 newly trained lifeguards in the ACT (106 in 2014), and 155 existing lifeguard qualification renewals. Over 360 (288 in 2014) additional Bronze Medallion recipients also joined the lifesaving community with basic water rescue skills.

Royal Life Saving ACT was thrilled this year with the commitment demonstrated by local swim teachers towards professional development in the industry. A record number of participants (68) undertook training in various AUSTSWIM extension programs including the 'Teacher of Infant and Preschool Aquatics', 'Teacher of Adults', 'Teacher of Access and Inclusion', and 'Teacher of Competitive Strokes' courses. Additionally, 156 new AUSTSWIM Teachers of Swimming and Water Safety completed their initial training through Royal Life Saving ACT, an approximate 9% increase.

Community education is just as much of a high priority as industry training for Royal Life Saving ACT. The number of Resuscitation course participants increased by over 16% with a total of 2243 CPR and/or First Aid qualified lifesavers graduating from these short courses in 2014/15. Many of these graduates completed their training via flexible and blended learning options that involved Royal Life Saving's unique First Aid product - First Aid in a Box. First Aid in a Box allows learners to commence the training in the comfort of their own home or workplace by completing online activities and quizzes prior to a shortened face to face assessment. First Aid in a Box continues to be the learning option of choice for some of Canberra's largest organisations and schools including Trinity Christian School and Burgmann College.

Training and Skills

In May 2015 Royal Life Saving ACT entered discussions with Royal Life Saving New South Wales about the use of the First Aid in a Box learning resource by the ACT Emergency Services Agency. The ACTESA hope to implement the resource into their standard in-service training program for all members of the ACT Fire Brigade and ACT Rural Fire Service at the beginning of the new financial year.

Other successful community training programs this year included ACT Emergency Services Agency Hydrotherapy Rescue conducted for staff at The Canberra Hospital, Hughes Hydro and Arthritis ACT; CPR Awareness – conducted for Scouts ACT; and Oxygen Resuscitation – provided for members of ACT Ambulance and Snowy Hydro South Care Helicopter Rescue Service.

2014 was a year of promoting partnerships and raising awareness for Royal Life Saving ACT and a lot of fun was had in undertaking these strategic pursuits. 

Special Projects

Inland Waterways Drowning Prevention

In early 2014 the Australian Government announced its commitment to
Drowning Prevention and Water Safety through the provision of peak funding
to the three key national Drowning Prevention and Water Safety
organisations: Royal Life Saving Society - Australia, Surf Life Saving Australia,
and AUSTSWIM. With 2 clear directives: 'Prevent drownings in Inland
Waterways' and 'Provide Swim and Survive access for children at risk of
missing out', Royal Life Saving ACT submitted a concept note to RLSSA for a
share in the funds. Based on intervention activities to be conducted in the ACT
with the collective goals in sight, the concept note was approved and Royal
Life Saving ACT set about planning campaigns, activities and events to
maintain a zero drowning rate.

The ACT Inland Waterways Drowning Prevention Project is now currently underway addressing water safety and drowning prevention issues in and around Canberra's lakes and rivers. The ACT project will continue to develop, implement and evaluate drowning prevention action plans for Lake Burley Griffin and the Murrumbidgee River Corridor, promote lifejacket use on vessels and watercraft on Lake Burley Griffin, assess the safety of community ponds, including those built in the urban environment, and facilitate water safety awareness and education at popular river-based recreation areas including community events.
